PROGRAM PROVISIONS

1. Program Name : Great 8th Anniversary Sweepstakes Program

2. Program Period : 1 February 2023 – 31 December 2023

3. Savings Products : J Trust Savings, Tora Savings & J Trust One Savings

4. Points Mechanism : Every increase in the average customer balance of IDR 1 million from the previous month will get 1 lottery number. The monthly lottery numbers will be accumulated until the lottery period ends.

5. Announcement Mechanism : The lottery winners will be announced on the official website of J Trust Bank or all J Trust Bank Branch Offices.

6. Chance to Win : Each customer will be given a chance to win only 1 time.

7. Tax Imposition: The 25% raffle tax of the total prize shall be borne by the customer.

- 8. Type of Prize:
 - a. Grand Prize 1 Deposit of @ Rp 100.000.000
 - b. Second Prize 3 Deposit of @ Rp 50.000.000
 - c. Third Prize 25 Savings @ Rp 2.500.000
- 9. This Lottery Program does not apply to J Trust Bank employees.
- 10. The decision of the winner of the lottery results is absolute and cannot be contested.
- 11. If during the draw, the account is declared as a passive account (dormant account) for 6 consecutive months then it will not be included in the draw.

REQUIREMENTS AND PROCEDURES

Documents that must be submitted to the Bank for account opening:

- 1. Indonesian Citizen: e-KTP with NIK registered in the Population Administration Information System and NPWP * (Especially for customers who are required to have an NPWP and already have an NPWP).
- 2. Foreign Citizens: Passport and KITAS/KITAP and Tax Identification Number (NPWP / TIN)*.
- 3. Company: e-KTP with NIK registered in the Population Administration Information System for authorized officials, NPWP, SIUP/Business License Number/Business Identification Number (NIB), Deed of establishment and/or company articles of association.
- 4. Fill out and sign the Account Opening Form.
- 5. Other supporting documents if needed such as Family Card (KK), Certificate of Domicile, Letter of Reference/Work Certificate.





*)For prospective customers who do not yet/do not have an NPWP, they are required to complete a statement letter that they do not have an NPWP, (provisions for customers who are foreign nationals if they do not yet/do not have a TIN, are also required to complete a statement that they do not have a TIN.
